## Oakland County Register Of Deeds Super Index

The Super Index site allows the public to search for documents in a very simple and easy way much like doing a Google search. One can simply enter the name of a party, a property address, a subdivision or document type of interest and find the documents that match their criteria.

### Simple Search Example

**Step 1: Perform Search** -- Type in the word "smith" and press the enter key.

## SUPER INDEX PROPERTY RECORDS SEARCH

### Boost Search Relevance

The Super Index site presents results for your search under four pre-sorted tabs: All Results, Names Only, Index Only, and Text Only. Results are sorted based on the relevance of the document to your search criteria. Just like with Internet search engines (Google or Bing, for example) search results are generated for a variety of reasons. Sorting the results by relevance is the key. The pre-sorted tabs named above and described below allow users to view results filtered and re-ordered by their relevance from an alternate perspective.

**By Name Matches** -- Boost relevance of documents where the search text matches not only names within the Grantor or Grantee fields, but also names that appear in another capacity in the document. This tab will show search results with “smith” in the Grantor or Grantee fields, but also perhaps results from a non-indexed piece of information like Notary Public or document preparer.

**By Indexed Field Matches** -- Boost relevance of documents where the search text matches Indexed fields. Fields that are indexed in the system include document type, date recorded, PIN, Grantor, and Grantee.

Please click on the "Index Only" tab to see relevant documents based on a match with information in one of the indexed fields.

## Using Navigators/Refiners

Search results can also be narrowed down by the list of information fields, or Navigators/Refiners, displayed to the left of the results. These fields break up the results into multiple categories and lists search results with counts for each including "Document Type", "Recorded Year", "Grantor", "Grantee" etc. Each field navigator can be filtered using the search box associated with it, based on the keyword entered.

### Advanced Search

One can perform interactive searches on individual index fields such as Grantor/Grantee, Recorded/File Date, Instrument Number, Document Type, Subdivision, Block and Lot. For example one can search for names under the Grantor field and see a list of matches as one types in the edit box. Press the enter key after completing your search criteria selections.

## Pay Per Use User Types

They will receive order confirmation email only to their email address associated with their PayPal account.




### How to Purchase a Subscription Plan

**Step 1: Selecting My Plan** -- To choose a subscription plan, go to the top right menu --  -- and click My Plan.








